Authorizing Resolution To Sign Contracts

Common Authorisation: Some of the Directors/Employees are assigned with a common authorisation to sign all the agreements or some type of agreements viz. commercial contracts, vendor contracts, etc. These authorisations are generally given at the time of their appointment itself and sometimes these authorisations are given during their employment through a board resolution.

Format of Board Resolution for Authorisation to Sign Agreement

Board Resolution for grant of authority to enter into ...

The treasurer (who also was a member of the church board) was the only person to sign the contract on behalf of the church. She signed her name without any reference to her official or representative capacity. The church constitution specified that sales of church property had to be authorized by the church board.

Authorization to sign on behalf of the company is the legal permission for an individual to sign official documents for a separate legal entity. Signing Contracts When you form a business as a corporation, the company becomes a separate legal entity.

Corporate resolutions for signing are particular resolutions that clarify and define which corporate officers have the legal standing to sign contracts on behalf of the corporation. Such resolutions also grant individuals the power to make transfers or assignments, sell or lease real estate, and make other important decisions that may affect the corporation.

A certified corporate resolution is a resolution made at a directors' or shareholders' meeting that has been approved by the secretary and president of the corporation. LLC authorization to sign is generally assigned to a managing member who has the authority to sign binding documents on behalf of the LLC. When signing, the managing member must clarify if the signature is as an individual or in their capacity to sign as the representative of the LLC.
