### **Get a vehicle log book (V5C) - GOV.UK**

Get vehicle information from DVLA Check online to find out what information the Driver and Vehicle Licensing Agency ( DVLA ) holds about a vehicle. You'll need the vehicle's registration number.

### **Get vehicle information from DVLA - GOV.UK**

You must send your old photocard licence to DVLA when you get your new licence. You'll be told the address to use when you finish the application. Your new licence will be valid from the date your application is approved, not from the expiry date of your current licence. Personal data DVLA will send you a confirmation email once you've applied ...
