Security Guard Renewal Application

A security guard as defined in Article 7A of the General Business Law [§89-f (6)] is a person (other than an active police officer) employed in NYS to principally perform one or more of the following duties, and the person is not performing the functions of a private investigator as defined in Section 71 of Article 7 of the General Business Law:

- When does an individual registration need to be renewed? Individual registrations are renewed every 2 years based on the date of issuance Registrations become renewable 90 days before expiration
- Who can renew an individual registration? The renewal application must be initiated by the registration holder, however, the payment may be submitted by either the individual registrant or the employer they are registered with.

Security Guard Renewal Application - All Risks, Ltd

Renew, replace or change information on a security guard or private investigator licence. If your licence or registration expires between March 16 and June 16, 2020, it will be automatically extended for 90 days. Before the extended expiration date of 90 days, you will need to submit a renewal application for the licence or registration, or it will expire.

The necessary forms for renewal of your security guard licence are mailed automatically from the Justice and Public Safety ministry either one year or two years from your initial application based on the amount of time you paid for. If you paid for a one year licence then you will receive a renewal form before the end of that one year period.

Renew your security guard licence

The security service licensing fee is \$100. Your licence is valid for 2 years. The renewal process is the same as the initial application. Security service workers can't hold a second licence as a locksmith or automotive lock bypass worker. Your individual licence is portable.

Security Guard Certifications - Maryland

The application review process may take longer if the application is found to be incomplete or if a police review is required. The application process for a new security guard license is as follows: The applicant submits an application online. All required documents must be uploaded before the application is submitted.
